Pursuant to the requirement of provisions of Regulation 29 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform that with the approval of appropriate authority the Bank has decided to exercise Call Option on BOI IPDI Bonds Series 3 (ISIN No. INE084A09142) and declare 26<sup>th</sup> September, 2017 as Record Date for this purpose.

The Bonds were issued on 11<sup>th</sup> October 2007 in pursuance of terms mentioned in Information Memorandum dated 13<sup>th</sup> July 2007 read along with addendum issued vide letter No. HO: TSR: dated 05.10.2007. The Bonds carry a coupon rate of 10.40% p.a. payable annually with perpetual maturity and call option on 11<sup>th</sup> October 2017. Upon payment of broken period interest and call option amount (Principal), by the Bank on 11<sup>th</sup> October, 2017, to the holders of the Bonds as on Record Date, the Bank's liability to the Bondholders towards all their right including for the payment or otherwise shall cease and stand extinguished.



We request you to take the above on record and treat the same as compliance under the applicable provisions of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015
