Allocations of costs :

- Expenses directly attributed to particular segment are allocated to the relative segment.
- Expenses not directly attributable to specific segment are allocated in proportion to number of employees/business managed.

1. The financial results for the quarter ended 30th June, 2011 have been arrived at on the same accounting policies as those followed in the preceding financial year ended 31st March, 2011.
2. The financial results have been approved by the Board of Directors at its meeting held on 25th July, 2011 and have been subjected to Limited Review by the Statutory Central Auditors of the Bank.
3. The financial results for the quarter ended 30th June, 2011 have been arrived at after considering extant guidelines of Reserve Bank of India (RBI) on Prudential norms for Income Recognition, Asset Classification and Provisioning and providing for other usual and necessary provisions including Employee Benefits on estimated basis.
4. A sum of Rs.31.32 Crore has been charged to the Profit & Loss Account during the period on proportionate basis towards the transitional liability of Rs.626.35 Crore upto 31.03.2007 calculated on actuarial basis in terms of Accounting Standard (AS-15) on "Employee Benefits" issued by the Institute of Chartered Accountants of India. The balance amount of Rs.93.95 Crore is being carried forward to be charged to Profit & Loss Account for the remaining quarters during this year.
5. In accordance with the RBI circular no. DBOD.BP.BC.80/21.04.018/2010-11 dated 09.02.2011:
 - a) a sum of Rs.110.61 Crore has been charged to the Profit & Loss Account during the period on proportionate basis towards additional liability of Rs.2212.15 Crore (being amortised over 5 years beginning from 31.03.2011) on account of reopening of pension option for existing employees who had not opted for pension earlier calculated on actuarial basis. The balance amount of Rs. 1659.11 Crores is being carried forward to be charged to Profit & Loss Account for future periods.
 - b) a sum of Rs. 21.45 Crore has been charged to the Profit & Loss Account during the period on proportionate basis towards additional liability of Rs.428.96 Crore (being amortised over 5 years beginning from 31.03.2011) on account of the enhancement of gratuity limits in Payment of Gratuity Act, 1972. The balance amount of Rs. 321.72 Crore is being carried forward to be charged to Profit & Loss Account for future periods.
6. The Provision Coverage Ratio as at 30th June 2011 is 66.76%.
